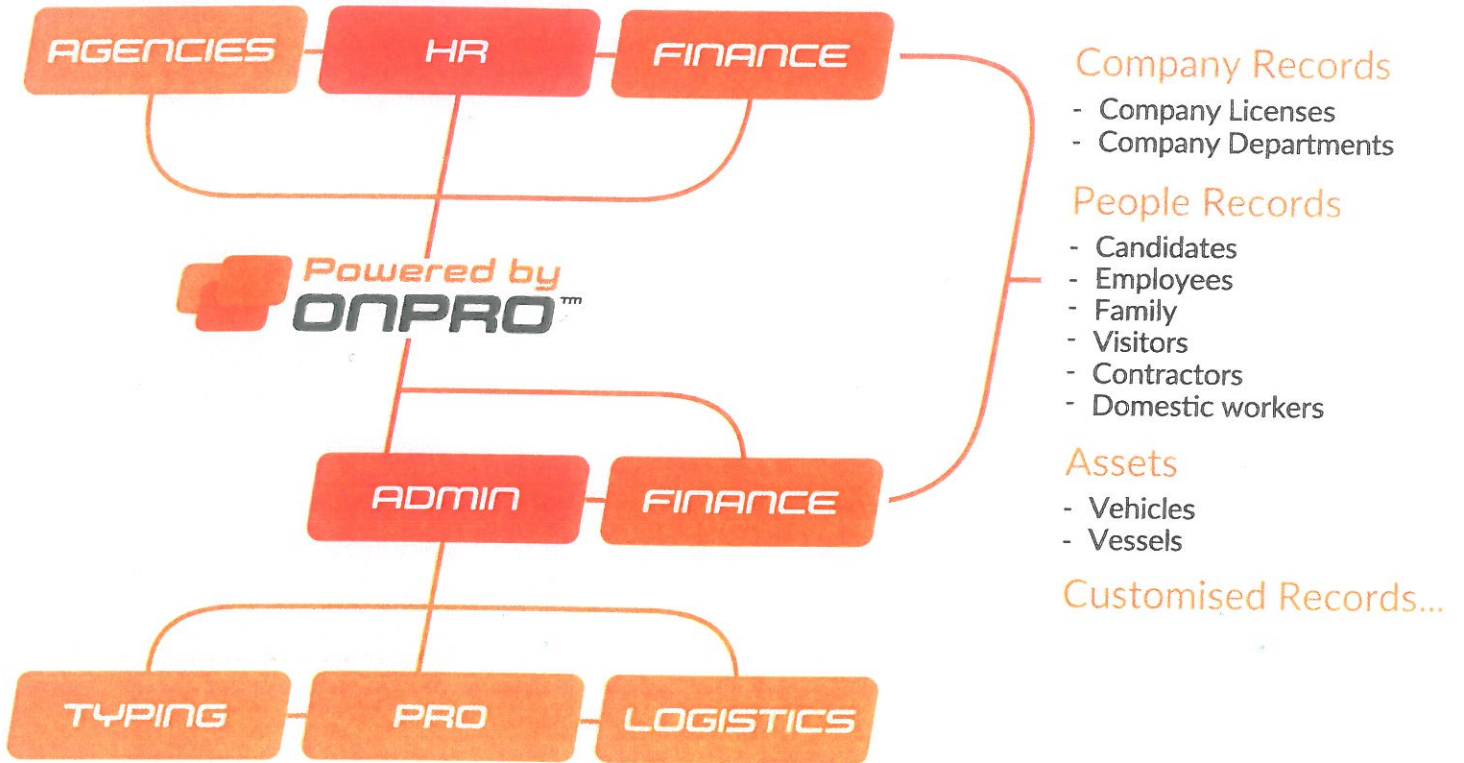

Internship is the training that employees of the organization do for their colleagues or subordinates. This type of training may not interest us while it has many benefits. Internship develops the skills of the trainer and the trainee and strengthens their relationship if done properly. In internal training, the focus is on the subject's applications in the organization and its problems. The trainer in internship is more keen to develop the skills of trainees. Internal training is inadequate due to the lack of experience of the trainer in the training or the lack of acceptance of the trainees to the idea of being a colleague. It may therefore be appropriate to train these trainers on training principles. Also, the trainer can always be in a higher job position than the trainees or be able to create an environment and culture that accepts learning from colleagues of the risks of internal training, the trainer does not prepare well for the training of the various sources and references, but relies on his experience only and this may lead to the transfer of the habits of the wrong work of the trainees. This problem can be avoided by training the trainers and supervising the training to ensure that the programs are well prepared. On the other hand, external training is characterized by the fact that trainers may have a broader training experience and have a deeper theoretical background (or process). External training adds ideas from outside the organization and allows employees to see another point of view and learn about the new. External training may have training tools that are not available in the organization itself. The training courses, in which more than one institution participates, allow the trainees to discuss, exchange experiences and learn about the experiences of other institutions, in addition to building good working relationships. External training may be impeded by the commercial aspect in the sense that the training provider may not care very much about the results of the training, but is interested in just holding the course and receive the material. The disadvantages of external training the trainers sometimes follow the method of creating training courses with attractive new names, while the training content is the same as the content of training courses previously offered by the employees. External training may be flawed after examples of the reality of the institution and after the training content on the needs of trainees. Both internal and external training advantages and disadvantages and therefore should be both in an integrated manner. Internal training is preferred in matters that the expert in the institution can transfer to those who are less experienced such as the transfer of the supervisor or engineer experience of the technicians or that the administrative manager to train workers in the technical sectors on the administrative aspects and so on. External training is shown in specialized training courses and courses related to modern science or applications.

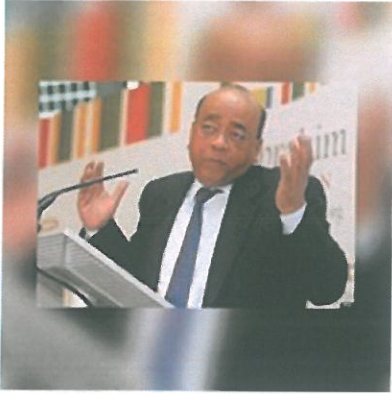

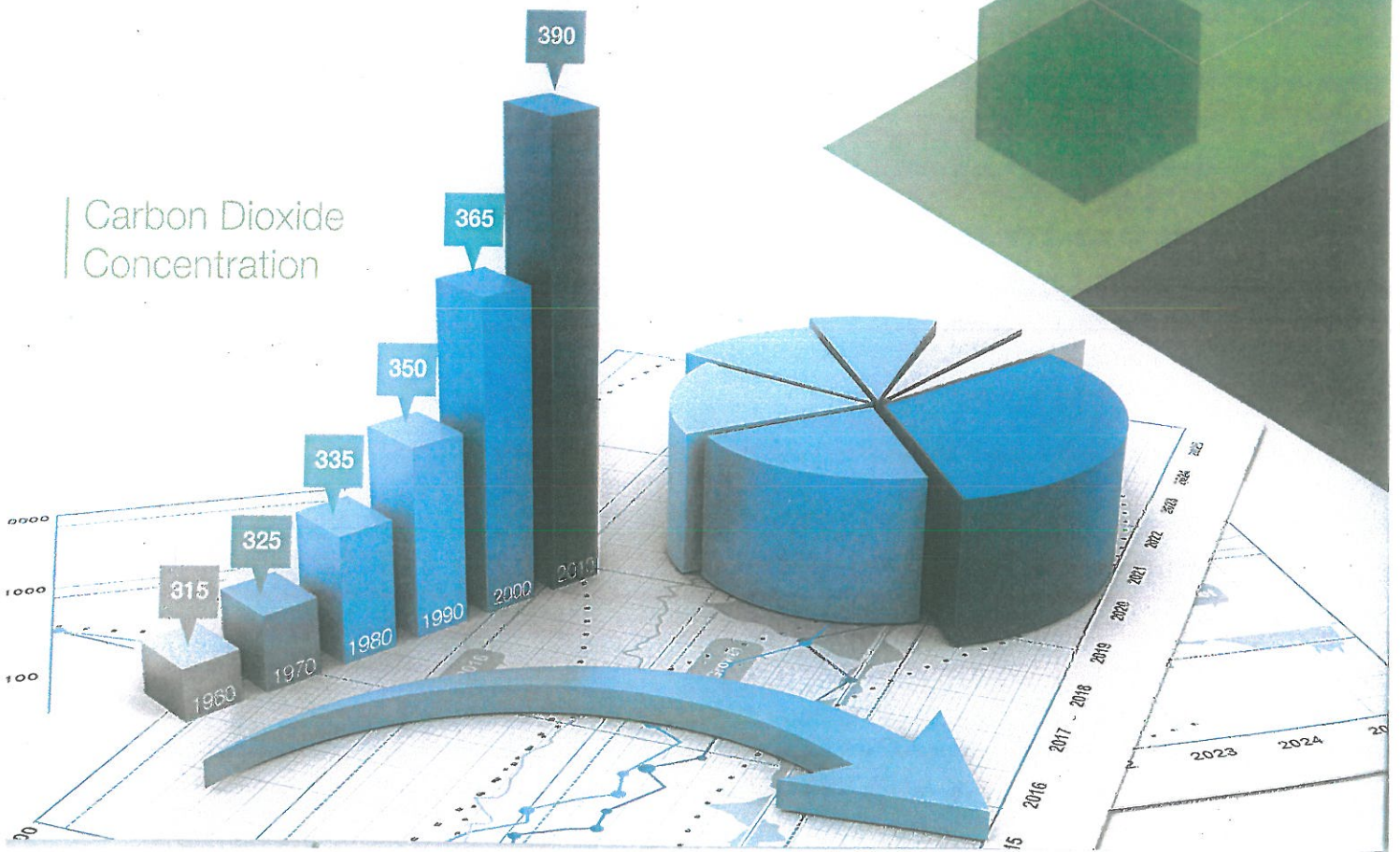

In the Arab world, the problem of pollution of beaches and seas is a serious threat to human and economic activity, which worries environmentalists. More than half of the Arab population lives along the coastal and marine areas they rely on sea water in tourism, summer and sea water desalination due to the scarcity of fresh water. The Mediterranean Sea is considered one of the most polluted seas, because it is a semi-closed sea, as its water is not renewed until about 100 years or more. The oil is characterized by its high ability to interact and spread in several forms and access to air, soil, freshwater, seas or oceans, and in various forms that depend on many vital, physical and atmospheric factors, all of these forms are very dangerous and may meet in a position of one form or more or all forms and the greater the number of these forms the more difficult to get rid off. There are a large number of harmful compounds contained in crude oil and all of which pollute the Earth and water environment, which are in the form of toxic organic petroleum contaminants or toxic organic pollutants, which include many hazardous compounds such as phenol compounds, cyanide compounds, sulfide compounds, toxic metal ions, soluble and suspended substances and hydrocarbons. And all these previous materials are working to destroy all types of dust, including fertile agricultural soil and turn into sterile soil does not benefit them. Liquid oil acts as a barrier between the soil and air grains and leads to poisoning and death of all the contents of the soil of their living organisms and degradation and then the death of plants, animals and insects, causing fully integrated into the ecosystem. Oil also has a direct toxic effect on plants and cultivated trees of all types and sizes. The oil that is attached to the vegetative group also prevents the gas exchange between the plants and the air and ultimately leads to its death.
